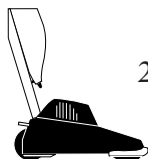

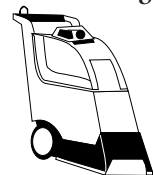
PRODUCT DATA



1. Always pretest for color fastness in an inconspicuous area before applying cleaning solution. Test with full strength product and allow to remain for at least three minutes. If color loss or fading occurs, do not proceed.



2. For best results remove furniture. Vacuum thoroughly and pretreat traffic lanes and heavily soiled areas.



3. Dilute product 1:64 in solution tank. Do not over-wet carpet. Add defoamer to recovery tank as necessary. Allow for sufficient dry time before reopening area to traffic. Place protective pads under furniture legs before replacing.
