DIRECTIONS:

1. Pre-test cleaner on carpet for colorfastness in inconspicuous area. Do not use if color is affected.
2. Remove furniture and dry vacuum thoroughly.
3. Remove stains and pre-treat traffic lanes.
4. Dilute product 1:16 with water (1:8 for foam machines) and shampoo across carpet overlapping each pass.
5. Do not overuse solution. Avoid overwetting.
6. Optional extraction with clear water may be done at this time. Be sure to add defoamer to recovery tank.
7. Set carpet pile in one direction with carpet pile brush.
8. Restrict all traffic until carpet has dried.
9. After carpet is dry, vacuum thoroughly.

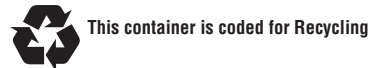
