

This V.O.C. compliant air freshener attacks airborne odors instantly.

TO DEODORIZE AIR: Spray with a wide sweeping motion. Use wherever odors occur and as often as needed to maintain freshness.

SPRAY REGULARLY: Use in bathrooms, sick rooms, basements, smoke filled rooms, offices—anywhere that odor is a problem. Keeps every room fresh and fragrant.

Do not expose to heat or store at temperatures above 120°F (49°C) as container may burst. Avoid prolonged exposure to sunlight. Use with adequate ventilation.

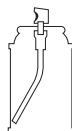
