DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not use in commercial food processing, preparation or storage areas.

SHAKE BEFORE USE, HOLD CONTAINER UPRIGHT.

APPLY IN SHORT BURSTS.

To Kill Flies, Mosquitoes, Small Flying Moths and Gnats: Close all doors and windows, and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and discard fallen insects.

Storage: Store in a cool, dry place (preferably locked) inaccessible to children and pets and away from direct sunlight, windows, flames or other sources of heat or ignition.

Disposal: Do Not Puncture Or Incinerate! **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.

PRECAUTIONARY STATEMENTS

Hazards To Humans & Domestic Animals

CAUTION: Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing vapors. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling. Do not spray on or near exposed food. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Do not use on humans, domestic animals or pets. Remove pets, birds and cover fish aquariums before spraying.

FIRST AID

IF SWALLOWED Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

IF INHALED Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.

IF ON SKIN OR CLOTHING Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

IF IN EYES Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

NOTE TO PHYSICIAN: Contains petroleum distillate - vomiting may cause aspiration pneumonia.
