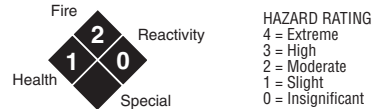
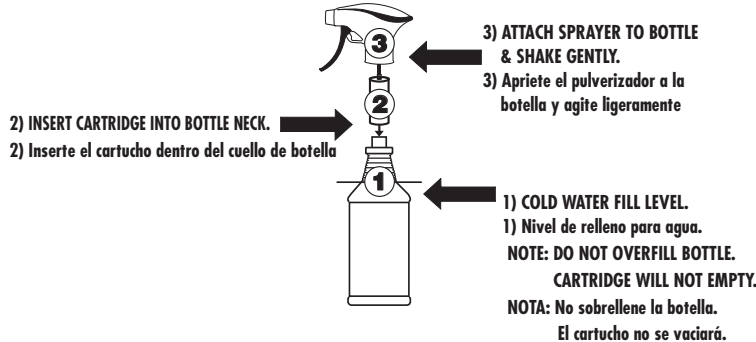

1. Mix 1 cartridge with clean cold water in 32 oz. work bottle.
2. Hold 6-8 inches from surface. Using trigger sprayer, apply directly to surface.
3. Always wipe from the bottom up.
4. When cleaning computer screens, do not spray directly on equipment. Spray on wiping cloth before cleaning.
