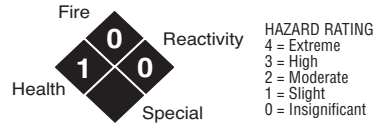
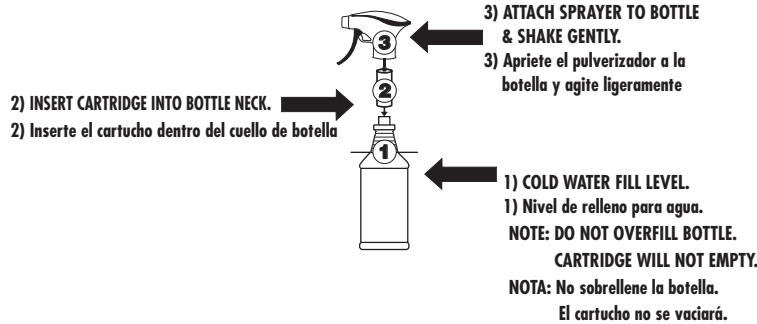

- Mix 1 cartridge with clean cold water in 32 oz. work bottle.
- Using a trigger sprayer, apply directly to surface. Hold 6-8 inches from surface.
- Always wipe from the bottom up.
