

RTU dilution of an EPA registered sanitizer for use on food contact surfaces. Excellent for use on clean-in-place equipment too large to bring to the three compartment sink. USDA D-2 Equivalent.

APPLICATION FOR USE: FOR SANITIZING FOOD PROCESSING EQUIPMENT IN MEAT AND POULTRY PLANTS, DAIRY EQUIPMENT, FOOD UTENSILS, DISHES, SILVERWARE, GLASSES, SINK TOPS, COUNTERTOPS, REFRIGERATED STORAGE AND DISPLAY EQUIPMENT, AND OTHER HARD NON-POROUS SURFACES.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing eye.

DIRECTION FOR USE:

To sanitize immobile items such as tanks, chopping blocks and counter tops, flood the area with a 200 ppm active quaternary solution or apply with a cloth or sponge making sure to wet all surfaces completely for at least 60 seconds. Let air dry. Prepare a fresh solution for each use.

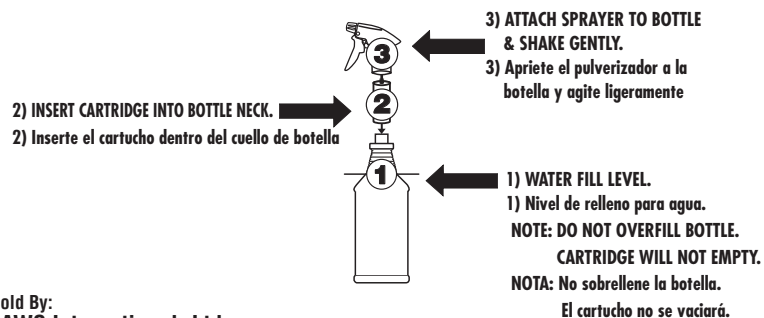
To sanitize mobile items such as drinking glasses and eating utensils, immerse in a 200 ppm active quaternary solution for at least 60 seconds making sure to immerse completely. Remove and let air dry. Prepare a fresh solution daily or more frequently as soil is apparent.

When used for sanitization of previously cleaned food equipment or food contact items, limit active quaternaries to 200 ppm. At this level **NO POTABLE WATER RINSE IS REQUIRED.** This product is an effective sanitizer when diluted in water up to 500 ppm hardness (CaCO₃)
