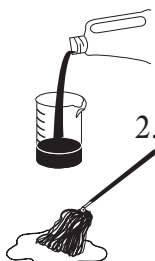

DIRECTIONS

PRODUCT DATA

1. Always dilute product properly. For regular floor stripping, dilute 1:9 (13 oz. per gallon) with cold water.



2. Apply liberally to small area of floor. Making sure surface remains wet until removed



3. Allow to remain approximately 10 minutes. (Double contact time for heavy buildup)



4. Agitate with single disc floor machine and black pad



5. Pick up with mop, vac, or automatic scrubber.

6. Clear water or neutralizer rinse.

7. Allow floor to completely dry.
