1. Always dilute product properly, and utilize proper protective equipment. Depending on soil buildup dilute 1:50 (2.5 oz. per gallon) for light soil, 1:20 (6 oz. per gallon) for regular soil, 1:10 (12 oz. per gallon) for heavy soil buildup.



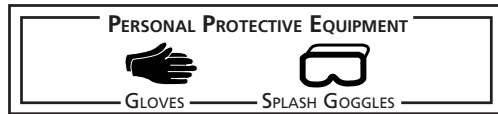
2. For use with auto scrubbing equipment dilute product 1:10 (12 oz. per gallon) in the solution tank. Add 1 oz. per gallon of defoamer to the recovery tank. Rinse equipment after use.



3. For use with pressure washer equipment dilute 1:10 (12 oz. per gallon) for regular soil and 1:5 (20 oz. per gallon) for heavy soil.
