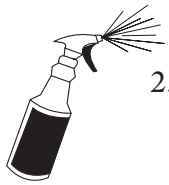

3. Wipe away soil with paper towel, cloth, or damp sponge.

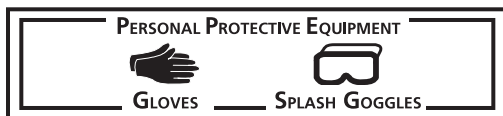


4. After surface has been cleaned, rinse thoroughly.
